


### NLC OPERATES AT THE BEGINNING OF THE RISK CURVE

MLC's risk curve — Invested capital







Reduces the carbon footprint of sterilization processes by an impressive 85%.





#### Challenges

Annually, 310 million surgeries worldwide require 1 billion sterile instrument sets, posing challenges such as patient infections, hospital inventory management, and significant plastic waste.

In the US alone, 115 million kg of plastic waste is generated yearly from sterilization consumables.



#### Solution

Ansana addresses these critical issues with their innovative smart sterilization container, which not only reduces surgical site infections but also eliminates the need for consumables during the sterilization process. Next to that, it optimizes the inventory processes for the hospitals.



#### Happy planet

Reduces the carbon footprint of sterilization processes by an impressive 85%.



#### Challenges

Osteoporosis, a chronic bone disease, impacts millions globally, with 1 in 3 women and 1 in 5 men facing osteoporotic fractures. Under-treatment persists, often due to inadequate diagnosis.

Limited accessibility and current technique limitations lead to latestage identification. Early screening can avert individual and socioeconomic burdens, including costly surgeries and waste generation.



#### Solution

POROUS quantitative ultrasound technology (QUS) aims at earlier and more precise osteoporosis diagnosis that could enable faster and more targeted patient treatment.

The POROUS technology offers a significant leap forward in the prevention of osteoporosis.



#### Happy planet

POROUS calculated CO2 emissions from their claim to reduce fragility fractures by 25%, focusing on hip fractures. This fracture prevention could reduce ~140,000 tonnes of CO2 annually by avoiding hip surgeries and rehabilitation.

An earlier study revealed screened patients gained an average 0.024 QALY (quality-adjusted life year).




### **Investment Case: CASHPOR India**



Why a HIB?

- Direct benefits: hospital care, phsysiotherapy, nursing and recovery
- Indirect benefits: lower health loss for seniors (DALY's)
- Bridging the fragmented responsibility and funding
- Opportunity to reach scale

#### **SOCIAL CHALLENGE- FALL PREVENTION**

EVERY YEAR IN THE NORTH-LIMBURG REGION, SENIORS EXPERIENCE 19.500 FALL INCIDENTS, RESULTING IN 7.000 MEDICAL TREATMENTS

Problem statement

- Fall incidents per year: 19.500
- Leads to medical treatments per year: 7.000

Screen 7.000 elderly for a high risk of falling

Goal

- Funding and organizing fall prevention courses for 2.500 elderly in five years
- Avoid 3.940 fall incidents
- Reduction in fall incidents and therefore in medical treatments
- Seniors feel **stronger and healthier**. Enhanced selfreliance and mobility



## **LEGAL AND FINANCIAL STRUCTURE OF THE HIB**

THE SPV FALL PREVENTION IS MANAGED BY SOCIAL FINANCE NL AND IS THE LEGAL INTERMEDIARY BETWEEN ALL DIFFERENT STAKEHOLDERS



## **OUTCOME PAYMENTS**

#### THE OUTCOME PAYMENTS WILL BE PAID ON THE BASIS OF THE REDUCTION IN THE NUMBER OF FALL INCIDENTS

- Outcome payments are based upon a single indicator: the number of fall incidents avoided
- The financial worth of an avoided fall incident is based upon two values:
  - Costs of a visit to the ER due to a fall incident
     (based upon analysis of VeiligheidNL)
  - Percentage of fall incidents leading to a visit of the ER (based upon analysis of VeiligheidNL)
- Based upon a ratio between age categories of 60%/40% (70-79/80+), expected outcomes are worth €4.44 million
- The Outcome payments will be paid after a measurement period of a year.

Age	Costs associated with visits to ER due to fall incident	Percentage fall incidents leading to visit of ER	Costs associated with one avoided fall incident
70-79	€6,051	3.8%	€229.72
80+	€12,444	18.8%	€2,339.31

# **MEASUREMENTS**

#### THE NUMBER OF FALL INCIDENTS WILL BE MEASURED BY DELOITTE AS AN INDEPENDENT ASESSOR

- The number of fall incidents will be measured by Deloitte, as an independent evaluator:
  - At the start of the intervention
  - After the intervention every six months for two years
- The difference between the baseline and the outcomes is the number of avoided falls
- Other questions asked i. e.:
  - Physical health
  - Quality of life
  - Daily life (scale 1-10)
  - Do you benefit from the intervention?
  - Referrals after screening other than fall prevention courses

## **ROLES IN THE HIB – INTERMEDIARY**


# FIRST RESULTS AND LESSONS LEARNED



THE FIRST RESULTS SHOW A REDUCTION IN THE NUMBER OF FALL INCIDENTS AND ALSO SHOW THE CHALLENGES FOR THE PROGRAMME WHERE REITERATIONS CAN BE MADE

#### The programme manages to reach participants well...

#### ...and leads to less fall incidents




- On average, participants give the program an 8.2 (ouf of 10) mean score.
- 80% of participants indicate they experience benefits from the programme, such as improved balance and muscle strength and improved selfconfidence.
- The first effect measurement among 54 participants show that 44 falls were prevented, which is a decrease of 65%. This puts us far above the expected percentage of 43% fewer falls.

# **LESSONS LEARNED**

AN UNIQUE COLLABORATION BETWEEN HEALTH INSURERS, MUNICIPALITIES AND INVESNTORS TO OFFER FALL PREVENTION COURSES TO 2500 ELEDERLY PEOPLE IN A STRUCTURED WAY

- Partially due to the HIB the 'ketenaanpak Valpreventie' was set up.
- Working together on a **regional level** has had many advantages. Such as extra publicity in the media and joint agreements in the medical domain. Coordinating regionally and organising locally works very well.
- Elaborate measurement of results and working data driven, possible to reiterate during the programme where necessary. This eventually leads to a more effective intervention.
- Through the HIB there is a bigger focus on the prevention of fall incidents. Because of this we focus on the **area** where impact is needed to be made.

#### **FALL PREVENTION IN THE MEDIA**

THE HIB STANDING STRONG HAS BEEN POSITIVELY FEATURED IN THE MEDIA, ALSO DUE TO THE CELEBRATION OF THE FIRST ANNIVERSARY OF THE PROGRAMME



Voorkomen is beter dan genezen. Zie hier de filosofie achter het project 'Stevig Staan', een valpreventieproject voor ouderen in Noord-Limburg. Minder vallen betekent minder opnames in het ziekenhuis en minder afhankelijkheid van de thuiszorg. Rabo &Co bezocht een informatiemiddag en de eerste praktijkles, allebei in Reuver. En sprak met letje Janssen uit Horst, een van de deelnemers. 'Ik zou het fijn vinden als er maandelijks een herhalingsbijeenkomst zou zijn.'



Steeds meer mensen overlijden na val, vooral ouderen slachtoffer

Steeds meer Nederlanders komen om het leven door een ongelukkige val. Vorig jaar overleden 6200 inwoners na een uitglijder, 15 procent meer dan in 2021, meldt het Centraal Bureau voor de Statistiek (2) (CBS).

Dat komt neer op zeventien fatale vallen per dag. Hiermee is vallen de meest voorkomende niet-natuurlijke doodsoorzaak, gevolgd door zelfdoding (1900 per jaar) en verkeersongevallen (772).



Het valpreventieprogramma van de Health Impact Bond 'Stevig Staan' ligt op schema. Ruim een jaar na de start van het vijf jaar durende programma, hebben 500 ouderen de valpreventiecursus doorlopen. Bernard ter Haar, voormalig topambtenaar en bestuurder van Social Finance NL.

#### Hoe moet het dan wel in de nieuwe polder?

'In Limburg loopt een experiment met valpreventie. Door de vergrijzing vallen steeds meer ouderen, met stijgende zorgkosten tot gevolg. Door trainingen te geven kun je dat verminderen, wat de zorgverzekeraars uitgaven scheelt. Als er aantoonbaar minder gevallen zijn, keren de gemeenten en zorgverzekeraars uit aan de investeerders in dit project, waaronder Rabo en BNP Paribas. Dat is een voorbeeld van slimme oplossingen in de nieuwe polder.
